# Attention Debit Card Holders Who Have Savings Accounts and No Checking Accounts.

For existing members who have savings accounts only and a Four Seasons Federal Credit Union Visa Debit Card for the savings account, we must regretfully inform you that we will be closing your debit card on September 3, 2013. The purpose of a debit card is to allow an account holder to make purchases against an open transactional account. This means these cards are issued only to members who have open checking accounts. Due to the purpose of the debit card, we can no longer allow debit cards to be active on a savings account only. In order to keep your debit card active, you must open a checking account before September 3, 2013. See a member service representative to see if you qualify. Please note: There will be no change to debit cardholders who already have an open checking account.

## Message from the President Life In The Fast Lane - We have loans for that!

During the long Memorial Day week-end, Becky and I traveled to Northeast Tennessee to visit our baby girl and our son-in-law. We make this trip several times every year, and over the past several years, I have noticed a trend taking place. The average age of the vehicles that we encountered had increased significantly. If you have shopped for a good used vehicle lately, then you know that this is true because there are fewer available, and when you find one, the price is high, sometimes close to the price of a new vehicle.

The trip over the Memorial Day weekend revealed a change in this trend. For the first time in a while, there appeared to be an increase in the new vehicles on the road. I spend a good deal of my driving time in the "fast" lane (Becky says that I feel the need to be the lead dog!), and this provides more opportunities to see who you are traveling with as you go by them. The number of new cars appeared to have increased significantly.

If you are one of the many who decided to hold on to your vehicle a little longer than you normally would, and now you have decided it is time to upgrade, then there are a couple of things to consider as you go in pursuit of your next vehicle.

First, don't be impulsive when you start your search. I have always been told that you should never go grocery shopping when you are real hungry because you will buy more than you need. This warning can also apply to your vehicle search, especially if you have been driving your current vehicle for a number of years. Remember, the person who is selling you the vehicle has to sustain themselves and their families on the income generated by their sales. It is in their best interest to sell all they can, but not necessarily in your best interest. Secondly, be prepared before you go shopping. Just as you don't go grocery shopping without knowing how much you can afford and how you are going to pay for it, you should not go shopping for a vehicle without the same consideration.

When you do decide to start the process of making your next vehicle purchase, please consider your credit union for your financing. We can pre-qualify you so that you are prepared to purchase when you find the right vehicle, or we can work with you after you find what you are seeking. We want to help you make the right choice. Remember, our primary concern is you, the member, not the sale.

#### **IRA Withholding Notice**

Payments from your IRA are subject to federal income tax withholding unless you elect no withholding. You may change your withholding election at any time prior to your receipt of a payment. To change your withholding election, you can complete the appropriate form provided by any of our IRA representatives.

Withholding from IRA payments, when combined with other withholding, MAY relieve you from payment of estimated income taxes. However, your withholding election does not affect the amount of income tax you pay. You may incur penalties under the estimated tax rules if your withholding and estimated tax payments are insufficient. 
#### We Welcome Two New Select Employee Groups (SEGs)
